- Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000
 Section 137(1) of the 1972 Act permits the Council to spend on pathities for which it has a section 137(1).
 - Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2020-21 was £8.32 per elector.
 - In 2020-21, the Council made payments totalling £2327.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.
- 2. The Balances Carried Forward is significantly higher than expected which was due to a number of project either cancelled or delayed due to covid19 and the restrictions. Two of the main projects was Queensway Play Area improvements with a budget of £20.000 which did not commence in 2020/21 and Street Lighting Upgrades with a remaining budget underspend of £36,143 as it did not commence until the last quarter.
