234. Apologies for Absence

Apologies for absence were received from Councillors Mr C Shone, Mr A Parsonage, Mr P Evans, Mrs M Williams and Ms A Williams.

235. Declarations Of Interest

There were no Declarations of Interest received.

237. Chairman's Announcements

There were no Chairman's Announcements.

238. Minutes of Council

RESOLVED: the Minutes of the Meeting of the Council held on 2nd November 2016, be approved as a correct record and signed, by the Chairman.

239. Visitors to Meeting

Mike Eastwood, Flintshire County Council – Streetscene attended the meeting to address any concerns or issues the Council may have.

Cllr L Griffiths raised the ongoing concern of visibility at the Caer Estyn crossroads due to a residents fence line obstructing the view. She also highlighted the safety concern that there is no street lighting or footpath on this crossroad. ME agreed to visit the site with Cllrs Griffiths and Pemberton to assess these concerns.

Cllr P Smith asked ME if there was a possibility of having a VAS (Vehicle Activation Sign) installed on Hawarden Road, Abermorddu. ME advised that this has now been approved and a sign allocated. The sign will be fitted shortly.

Cllr B Hughes asked whether any progress has been made regarding the issue raised previously of the road surface outside of the White Lion. ME advised this site was reviewed and the large manhole surface has not been worn and is sufficient. BH advised there can be excess water on the road due to blocked gullies. ME has agreed to request these to be cleared.

Cllr Cunnah raised the matter of continued fly tipping by the old Hope Tip which ME responded by saying he was aware of this and it is checked and cleared on a regular basis. Also there has been road flooding on Pigeon House Lane (by the railway bridge) which ME agreed to assess and ensure gullies are clear.

ME advised that the request for yellow lines to be installed on the corner of the Red Lion has been put forward for recommendation which will be reviewed and scored on a matrix, however, only the top 5 across the county will be action this year.

*Mike Eastwood left the meeting at 6.45pm

240. Matters Arising

Cllr Cunnah provided the Council with a brief report on the OVW (One Voice Wales) Meeting she had attended. She was informed by Mr Arfon Jones Police and Crime Commissioner that their current key priorities are: violence, modern slavery and child sexual exploitation. He also advised and encouraged viewing of Engagement Plans where local PCSOs are members of the Safer Neighbourhood Scheme.

Cllr P Smith also provided the Council with a brief report of the South Flintshire Police Consultation where the Year Report was issued. The main spike of police activity for the year was in the Caergwrle area. Cllr Smith informed the Council that the police force is slowly diminishing due to Officers not being replaced that are either retiring or being promoted elsewhere.

Min 215/176(ii): County Councillor Healey asked whether any Council members could assist in volunteering for the Community Speedwatch Scheme. He also advised that it would be unlikely that any sessions would be held during the winter.

Min 201: Clarification was received from County Councillor Newhouse regarding the financial situation of the Hope Sport & Social Pavilion (Hope Hwb). He advised *the £250,000 figure he had previously suggested was a rough indication of the build cost. The tender insists that the Hwb is built meeting all of the plans and specifications. After that the developer will then be allowed to sell two new builds*'.

Min 202/169: Unfortunately both County Councillors Healey and Newhouse were unable to attend the December Meeting.

RESOLVED: the above be received and noted.

242. Community Council's Draft Estimates for 2017/18

The Council considered the draft estimates for 2017/2018, a copy having been enclosed with the agenda for the meeting. The Clerk also circulated a further amended draft at the meeting together with a report detailing significant variance to expenditure.

The Clerk also informed the Council that notification has been received from Flintshire County Council advising that the estimated 2017/18 Election costs for the wards Hope and Caergwrle could be £6,000.

The main areas of possible significant new expenditure to be considered were, upgrading Christmas lighting, installing CCTV cameras, Chain of Office, Training and Elections.

It was proposed that the Council's precept be set at the January 2017 meeting and Councillors were invited to comment on the estimates before them and discuss any amendments which they would wish to be included in the final figures before considering approval of the budget and the precept next month. The Council also requested the Clerk to obtain a Street Lighting Report to ascertain the condition of the columns, number of columns that require updating and costs of repairs for the previous 2 years.

RESOLVED: the Clerk will obtain the street lighting information and prepare a report for the January Meeting. The estimates as circulated be noted and that the Clerk prepare and submit the final estimates to the next meeting for consideration with a view to setting the Council's precept for 2017/18.

243. Community Youth Club

As this item has been requested by Cllr P Evans it was resolved for it to be carried forward for discussion at the January Meeting.

Cllr Pemberton did suggest that once the Sports Pavilion is complete there could be possible options to use this facility.

257. Matters Arising

Minute 226 (i): following the Council's response to County Councillor Healey he was disappointed with the reply which did not answer the questions he had submitted and has asked to ensure all Councillors have received the document. The Clerk has confirmed that all members were issued with a copy in advance of the November meeting.

RESOLVED: the Council are satisfied with the response to Cty Cllr Healey and no further action will be taken.

258. Disposal of the Telephone Kiosk - Abermorddu

Following the resolution at the November meeting to consider disposal of the kiosk, County Councillor Healey informed the local newspapers which generated a number of interested parties. The interest varied from people taking and removing the kiosk to volunteering to raise funds to get the kiosk restored.

Cllr Parry presented concerns on behalf of himself and local residents regarding disposing of the kiosk and urged the Council to withdraw the proposal. He feels that it would be a breach of contract and integrity if the council proceeded with the sale.

Cllr Parry suggested the Council should consider other options including donations from fund raising and other means. He has also offered his services to assist with the restoration of the kiosk.

RESOLVED: the comments from Cllr Parry were received and noted and will be included on the January agenda.

262. Caergwrle Railway Station

Cllrs P Smith and Waterhouse informed the Council of the Arriva Trains Adopter Scheme.

The scheme has similar objectives to the 'Neighbourhood Watch' scheme where local people help by keeping an eye on unstaffed railway station.

As an adopter, the basic requirement is to submit at least two reports a month about the condition of the station. Reporting on matters such as litter, graffiti, vandalism, lighting, information help points and timetable information. If there are any issues that might need addressing, the Station Manager will ensure the maintenance operatives are aware so that they can be addressed.

There is no financial commitment to an adopter and there is no requirement to undertake any cleaning or maintenance issues as these are done on a weekly basis by Arriva staff. You can adopt a station as an individual or as part of a group.

Adopters receive an annual travel vouchers to the value of £75 for an individual or £200 for a group. These can be used on any part of the UK rail network.
