### 260. To receive any Public Questions/Correspondence.

i. An email had been received regarding the request for a salt bin on Kiln Lane, however, further communication has been received to advised that FCC have this in hand.

- ii. Two emails were received regarding the removal of the telephone kiosk.
  - a. A request to have the kiosk relocated at a residential property and they would cover the removal costs. The Clerk responded to inform the resident that FCC have advised against relocating due to the uncertainty of the structure.
  - b. An email challenging the council's decision to remove the kiosk. The resident is making enquires with Cadw and is requesting for the community council to reverse its decision to dispose until Cadw have reached a position on awarding a potential preservation Listing order.

The Chair reported that in accordance with Standing Orders a resolution shall not be reversed within six months except either by a special motion, which requires written notice by at least 6 councillors to be given to the Proper Officer or by a motion moved in pursuance of the recommendation of a committee or a sub-committee.

**RESOLVED:** the above will be communicated to the resident and no further action will be taken at this time. FCC were instructed to dispose of the kiosk in December 2022.

iii. An email from a resident requesting to raise an issue with FCC Streetscene (as Mr Williams was due to attend) regarding the lack of response from FCC Streetscene in relation to an outstanding brown bin collection. The bin has been left out since the Tuesday prior to the final collection on the 10/12/22. As Mr Williams had submitted his apologies to the Clerk, she informed the resident that this would be reported to full council and that she would raise directly with Mr Williams.

**RESOLVED:** this will be raised with Ian Williams, FCC Streetscene.

### 261. County Councillor Report

Cty Cllrs David and Gladys Healey haven't been able to submit a report, but did provide a copy of the Heartbeat and a leaflet produced by the Alyn Villages Age-Friendly and Dementia Group.

He also reported that there is no further news on the FCC Budget apart from that the gap is now around £13.5M. The LDP has now been passed by Council and although they sat this item out because of their previously declared personal and prejudicial interest they did have a Dispensation from the Standards Committee which allows him to oppose the Bluebell Field development.

Cllr Oldham advised that she had communicated with Cllr D Healey regarding the 2x council houses on Hawarden Road. At present these require a full refurbishment which is restricted due to the financial restraints of FCC.

### 286. Caergwrle Castle

- i. Members were provided with a copy of the meeting notes of the meeting held with the Castle Working Group and Flintshire Countryside Services on 26th January. The Chair reported that it had been a very constructive and positive meeting.
  - FSC are looking at options to update the noticeboards/signage and have also provided the original quotes for the replacement steps approx. £11,500 (quotes dated late 2021 and prices would now have increased). At present the steps are structurally safe but do look tired. Cadw were approached for a grant, but no response was received. Due to the cost, Cadw will be pursued for financial support.
- ii. The Chair reported that Cllr Arnold attending a meeting of the Flintshire Historical Society where one of the lectures was by Jo Lane who is the Project Officer for the Bailey Hill Project in Mold. It was very informative and they have offered to liaise with the council for support.
